## Features

The DOW FILMTEC<sup>™</sup> Industrial Grade, BW30-400-IG high rejection brackish water reverse osmosis (RO) element is designed for use in industrial water treatment applications. It maintains the same flow and rejection performance of the BW30-400 elements, but does not carry the ANSI standard 61 or KIWA certifications, offering a more cost effective option for industrial applications.

- BW30-400-IG elements may be cleaned over a wide pH range (pH 1-13). •
- The BW30-400-IG is a drop-in replacement for the BW30-400 in systems that do not require drinking water certifications.

Important Information	Proper start-up of reverse osmosis water treatment systems is essential to prepare the membranes for operating service and to prevent membrane damage due to overfeeding or hydraulic shock. Following the proper start-up sequence also helps ensure that system operating parameters conform to design specifications so that system water quality and productivity goals can be achieved.
	Before initiating system start-up procedures, membrane pretreatment, loading of the membrane elements, instrument calibration and other system checks should be completed.

Operation Guidelines	<ul> <li>Avoid any abrupt pressure or cross-flow variations on the spiral elements during start-up, shutdown, cleaning or other sequences to prevent possible membrane damage. During start-up, a gradual change from a standstill to operating state is recommended as follows:</li> <li>Feed pressure should be increased gradually over a 30-60 second time frame.</li> <li>Cross-flow velocity at set operating point should be achieved gradually over 15-20 seconds.</li> <li>Permeate obtained from first hour of operation should be discarded.</li> </ul>
General Information	<ul> <li>Keep elements moist at all times after initial wetting.</li> <li>If operating limits and guidelines given in this bulletin are not strictly followed, the DOW™ FILMTEC™ Reverse Osmosis and Nanofiltration Three-Year Prorated Limited Warranty (Form No. 609-35010) will be null and void. Please refer to the Limited Warranty for more information.</li> <li>To prevent biological growth during prolonged system shutdowns, it is recommended that membrane elements be immersed in a storage solution.</li> <li>The customer is fully responsible for the effects of incompatible chemicals and lubricants on elements.</li> <li>Maximum pressure drop across an entire pressure vessel (housing) is 50 psi (3.4 bar).</li> <li>Avoid static permeate-side backpressure at all times.</li> </ul>
